


The Second Annual General Meeting of the SLPA-UAE

Dubai, 10th June 2021: The Second Annual General Meeting (AGM) of the Sri Lankan Professionals Association in the United Arab Emirates (SLPA-UAE) held on Saturday, 22nd May 2021, as an online event through the Zoom platform. The AGM have had forty-three (43) participants including the Patrons and the Central Committee/Board Members of the respective member associations.

5. The Association of Quantity Surveyors of the University of Moratuwa-UAE (QSUM-UAE)

6. Sri Lankan Hospitality Professionals Association in the UAE (SLHPA-UAE)
7. Sri Lankan Information Technology Professionals Association in the UAE (SLITPA-UAE)

The commencement of the event has been marked by honouring the National Anthems of the UAE and Sri Lanka, followed by a one-minute silence for the commemoration of the fallen heroes and the people who have succumbed to COVID-19 around the world.

The welcome speech was delivered by the Chairman of the SLPA-UAE, Mr. Ajantha Premarathna. In his speech, Mr. Premarathna has notably welcomed the Sri Lankan Hospitality Professionals and the Sri Lankan Information Technology Professionals who joined the SLPA-UAE as the two new Member Associations. Furthermore, he has described the formation of the SLPA-UAE and its significant progression from the inception on 28th May 2019 to date, and the upcoming challenges which must be overcome by the succeeding Executive Board to be shortly appointed.

The Chairman has conveyed his earnest thankfulness to all the past and present Executive Board Members for their praiseworthy guidance and contribution towards the formation of the SLPA-UAE and in elevating its image to the current state. He was further appreciative of PIMA-UAE for appointing him as an Executive Board Member of the SLPA-UAE and apologetic if he was rigid to some extent in meeting the unified interest of the SLPA-UAE.

Thereafter, the Annual Report for the Year 2020-2021 has been presented by the Secretary of the SLPA-UAE, Mr. Lalith Gallage.

In the Annual Report, Mr. Gallage has described the current structure of the Executive Board of the SLPA-UAE, and specifically emphasized on the delivery of 42 activities including Continuing Professional Development (CPD) events, a Training Programme on Leadership Development, assisting the Sri Lankan Cultural Education Centre in Dubai by providing video conferencing facilities, supporting the community projects organized by the Sri Lankan Welfare association (Sahana) and preparing a cost estimate for the proposed Buddhist Temple in Abu Dhabi by IQSSL-UAE, despite the current pandemic situation. Furthermore, SLPA-UAE has secured corporate discounts from a few major hotel chains, so that the benefits can be availed by its membership.

After the conclusion of the annual report, the financial statement for the Year 2020-2021 has been presented by the Treasurer of the SLPA-UAE, Mr. Nalaka Kantharachchi.


